Dissolution of partnership is the end of partnership only. if one partner of a firm dies retires or adjudged insolvent. the remain partners may agree to continue the firm under the same name. the remaining partners may purchase the shares of the outgoing or deceased partner by signing a fresh agreement. The firm can thus continue its business.

Definition of Dissolution of Firm The composite entity for all the partners is called firm. It is the concrete form of all the partners who are linked together. Dissolution of a firm takes place when the jural relation present between all the partners no longer exist, i.e. the partnership between each and every partner of the firm is put to end.
