If an item has no author, start the citation with the article title. When an article has one to seven authors, all authors' names are cited in the References List entry. When an article has eight or more authors list the first six authors followed by three spaced ellipse points (...), and then the last author's name.

If the quotation is less than 40 words, incorporate the quotation into the text and place quotation marks round the quotation.

If there is no DOI and you have accessed the article electronically, include the web address of the journal's homepage in which the article was published in your reference.

### **Journal article - APA 6th referencing style - Library ...**

Up to five names can be included, but in the subsequent in-text citation for works with more than two authors, write only the last name of the first author followed by et al. Last name, A. A., & Last name, B. B. Carlson, R. G., & Lee, M. R.\*Use ampersand (&) instead of "and."

### **APA PDF Citation | APA Format**

For an APA citation for a journal article with 2 to 20 authors, use a comma between all of the author names. Place an ampersand (&) before the final author's name. For an article with 21 or more authors, list the names of the first 19 authors and use a comma between all of the names.

### **How to Cite a Journal in APA | EasyBib**

Add a comma after the parentheses, and then include the page range of the article (for those articles with designated page numbers on each page of the article). Add a period after the page numbers. Then, add the DOI using the current standard of the DOI, which starts with <https://doi.org/>.

How to Cite a Journal Article in Print or Online in APA Format Articles differ from book citations in that the publisher and publisher location are not included. For journal articles, these are replaced with the journal title, volume number, issue number and page number.
