To start a civil lawsuit in Minnesota, a person or company must have a Summons and Complaint served on (delivered to) another person or company or ask them to waive formal service. The party starting the lawsuit is usually called the plaintiff, and the party being sued is called the defendant.

Grant pursuant to an act of March 3, 1871 (16 Stat. 514), authorizing the President to prescribe rules and regulations for the civil service. Superseded by the U.S. Civil Service Commission, 1883. Rights of Servicemembers in Civil Court Cases A federal law called the Servicemembers Civil Relief Act (SCRA) allows members of the U.S. military to suspend or postpone some civil legal responsibilities while on active duty. Overview of Minnesota's Civil Statute of Limitations The time limits for civil claims and other actions in Minnesota vary from two years for personal injury claims to 10 years for judgments. Fraud, injury to personal property, and trespassing claims have a six-year statute of limitations, as do both written and oral contracts.
