The New York City Early Intervention Program (EIP) is committed to ensuring that children in foster care receive a timely Multidisciplinary Evaluation (MDE) to establish eligibility. Once eligibility has been established, an Individualized Family Service Plan (IFSP) meeting will be held within forty-five (45) days of referral to the EIP.

The New York State Department of Health, in its capacity as lead agency for the Early Intervention Program, is responsible for the general administration and supervision of municipalities and early intervention service providers, including the monitoring of all activities necessary to implement all requirements under the federal Individuals with Disabilities Education Act (IDEA) and Title II-A of Article 25 of New York State Public Health Law (PHL).

The New York State Early Intervention Program (EIP) is part of the national Early Intervention Program for infants and toddlers with disabilities and their families. First created by Congress in 1986 under the Individuals with Disabilities Education Act (IDEA), the EIP is administered by the New York State Department of Health through the Bureau of Early Intervention.
